Volunteer Role Description Brockholes Nature Tots Volunteer

About the Lancashire Wildlife Trust

We are part of the Wildlife Trusts movement, the UK's leading conservation charity dedicated to all wildlife. We are your local charity, working hard to improve your local area for wildlife and for you.

The Trust manages over 2,000 acres of some of the region's most precious wild places in the form of 37 nature reserves and 20 Local Nature Reserves. These provide places where wildlife can thrive and people can relax and enjoy the wealth of our natural heritage.

What is a Brockholes Nature Tots Volunteer?

Nature Tots is based predominantly outdoors and has an emphasis on the little ones having fun and learning through nature. Nature Tots is designed for young children (age 15 months – 5 years) and their parents/guardians. Sessions are run at Brockholes every Friday during term time, 9.30am–10.45am and 11.15am-12.30pm and are based around interactive activities. Each week there is a different theme, around which the activities are based. Previous sessions have included nest building, frogs and toads, fairies, owls, natural art and many other fun themes. This helps the youngsters stimulate independent learning and team work, which will help to boost communication skills, problem solving, physical development and creativity.

We are looking for an enthusiastic, friendly and reliable volunteer who would like to help regularly with Nature Tots at Brockholes on Friday mornings (8.30am – 1pm).

- Are creative and are able to help develop session ideas and activities suitable for Early Years Foundation Stage (EYFS).
- Are enthusiastic and want to engage people, especially children, with the natural environment.

- Have a friendly nature.
- Have some knowledge of resources, which can be used for activities.
- Enjoy working outdoors in all weathers.
